

BOAT SLIP RENTALS—Boats can be docked at one of our rental slips: 20, 24, 26 or 30-foot. Fresh water, electrical power, and a screened fish cleaning station are provided.

RENTAL RATES — Check the current rates listed on the website trailerestates.com under the "Rentals" tab and then "Marina" on the drop down.

BOAT RAMP—A private ramp provides access for boat slip renters during weekdays (8-5) and Saturday mornings (8-12). After hours boat ramp access is on an emergency basis only.

BOAT SLIP RENTAL LEASE

RESTRICTIONS—

- No overnight use, and
- No commercial use by boat slip renter.

REGISTRATION AND INSURANCE—

Requirements for boat slip rental:


- Current boat registration, and
- Boat liability insurance: Minimum of \$100,000 coverage.

CHARGES FOR EXTRA SERVICES—

- <u>Electric power usage</u>: No charge for 24 hrs.;
 beyond 24 hours a charge of \$5 per day.
- Emergency assistance: \$60 to \$210 for up to 2 hrs. of emergency assistance.
- After hours boat ramp emergency: \$60 for up to two hours.

DOCKING LINES

pocking Lines—Boat slip renters are required to utilize 6 docking lines at a minimum; 2 fore, 2 aft and 2 spring—1 front 1 back. Boats under 27 feet in length, must use at least 3/8-inch diameter docking lines. Boats sized 27 - 30 feet in length must use at least 1/2-inch docking lines. Additional lines may be required for safety. Docking lines must be maintained in good condition and must be replaced when they begin to show signs of wear. When departing, docking lines must be placed on the dock in a safe manner. No lines are to be left lying across pier walkways.
